## SECTION 4 – FIRST AID MEASURES

<b>Inhalation</b>	Remove person to fresh air away from exposure. Remove contaminated clothing and loosen remaining clothing. Allow patient to assume most comfortable position and keep warm. Keep at rest until fully recovered. Obtain medical attention if symptoms occur.
<b>Skin contact</b>	If skin or hair contact occurs, remove contaminated clothing and flush skin and hair with running water. If swelling, redness, blistering or irritation occurs seek medical assistance. Continue to flush skin and hair with plenty of water (and soap if material is insoluble).

## SECTION 6 – ACCIDENTAL RELEASE MEASURES

### Emergency Procedures

Wear PPE in accordance with Section 8 of this SDS. Minor spills Avoid inhalation of vapours or dust. Wipe up with absorbent (clean rag or paper towels). Collect and seal in properly labelled containers or drums for disposal.

In the event of a major spill, prevent spillage from entering drains or water courses. Wear appropriate personal protective equipment and clothing to prevent exposure. Increase ventilation. As a water-based product, if spilt on electrical equipment the product will cause short-circuits. If possible, contain the spill. Place inert absorbent material onto spillage. Collect the material and place into a suitable labelled container. Dispose of waste according to the applicable local and national regulations. If contamination of sewers or waterways occurs inform the local water and waste management authorities in accordance with local regulations.

## SECTION 7 – HANDLING AND STORAGE

### Handling

Avoid skin or eye contact with concentrate. Wear protective clothing when risk of exposure occurs. Avoid contact with incompatible materials. When handling, DO NOT eat, drink or smoke. Keep containers closed at all times. Avoid physical damage to containers. Always wash hands with water after handling. Launder contaminated clothing before re-use.

### Storage

Store in a cool, dry, well-ventilated place and out of direct sunlight. Store away from foodstuffs. Store away from incompatible materials described in Section 10. Store away from sources of heat and/or ignition. Keep container standing upright. Keep containers closed when not in use - check regularly for leaks.
